CASPS News

Launching CASPS Working Paper Series

We are delighted to announce the launch of CASPS' Working paper series. Entitled 'Bath Papers in Social Welfare, Policy & Society'. It aims to provide a platform for CASPS affiliated researchers, SPS students and colleagues external to CASPS to share early versions of research work, interesting findings or theoretical pieces of work. The series operates with light anonymized peer review (Bath-based unless stated otherwise) to encourage good quality submissions. Our first working paper is entitled: "Dualization and Welfare in the 21st Century: A Literature Review and a Proposal for a Conceptual and Explanatory Framework". It is co-authored by two colleagues based in Spain: Jorge Hernández-Moreno, from the Institute of Public Goods and Policies (IPP) & Centre for Human and Social Sciences (CCHS) and Gibrán Cruz-Martínez from the Faculty of Political Science and Sociology Complutense University of Madrid (UCM).

CASPS' partnership with School for Health Policy, Western University (Canada) is renewed

Western's Faculty of Health Sciences (Canada) and the Faculty of Humanities and Social Sciences at the University of Bath (UK) have renewed their memorandum of understanding (MOU) lead to health and welfare focused collaborations between the two institutions. The agreement includes Western's School of Health Studies and Bath's Department for Health and the Centre for Analysis of Social Policy and Society. CASPS collaboration will involve co-organizing joint research-focused work and events like the joint event – *Health Equity Issues: Soundbites from across the world* – which CASPS led in 2022 when academics from around the globe spoke for three minutes each about the major health equity issues affecting their respective countries.

CASPS and MEGRI collaboration receives support from the Great Britain Sasakawa Foundation

Since 2019 the Centre for the Analysis of Social Policy and Society (CASPS) at the University of Bath has been collaborating with the Medical Governance Research Institute (MEGRI) based at Tokyo, Japan, on examining and comparing the rules governing the disclosure of payments that pharmaceutical companies make to the healthcare sector in the UK and Japan. Key findings from this phase of our research have been published in a major comparative paper published in Globalization and Health. Our new research project, was generously funded by The Great Britain Sasakawa Foundation (early 2024), and seeks to examine why, compared to the UK, the pharmaceutical industry in Japan has more comprehensive transparency rules regarding some aspects of collaborations between the pharmaceutical industry but not others. This research will draw on a new data source – qualitative interviews with stakeholders involved in pharmaceutical policymaking in Japan. The partnership is led by Dr Piotr Ozieranski (CASPS) with support from Dr Theo Papadopoulos and Dr Akihiko Ozaki, Medical Governance Research Institute (Tokyo, Japan). It involves a large number of activities, including visits of medical students from MEGRI to CASPS. This collaborative research brings together insights from social scientists, policy experts and medical professionals. We look forward to taking it further thanks to the support of the Great **Britain Sasakawa Foundation!**

CASPS forges collaboration with NatCen International (National Centre for Social Research)

Over several months CASPS has been strengthening links and collaboration with colleagues from NatCen International (National Centre for Social Research). This partnership is led by Dr Sherine El Taraboulsi-McCarthy, Director of NatCen International and Dr Theo Papadopoulos, co-Director of CASPS. We had the pleasure to welcome Dr Taraboulsi-McCarthy in an online seminar exploring 'Complexity Theory and Asylum Seekers Decision-making' while an expert commentary was co-authored by the two leads on the importance of social policy and social cohesion in global action to tackle the poly-crises of our times. Community Summit: Addressing children's needs in Bath and North East Somerset

A major event – the first of its kind - was hosted by Centre of Analysis of Social Policy in partnership with Bath and North East Somerset Council, SARI (Stand Against Racism) and St John's Foundation. It brought together many local stakeholders who participated in discussions and workshops that explored the critical issues surrounding children's wellbeing, poverty and socioeconomic deprivation in our region, especially in the areas of mental health, education, justice and discrimination, socio-economic deprivation. The summit also discussed the potential for setting up a collaborative Socio-economic Observatory for BANES to be hosted by CASPS. The event opened with welcoming words from Mohammed Saddig DL, HM Lord-Lieutenant of Somerset, Robert Drewett DL, High Sheriff of Somerset, Cllr Paul May, BANES Lead Member for Children and Young People, Dr Alex Raikes MBE DL, Director, SARI charity (Stand Against Racism and Inequality) and Prof Cassie Wilson, Pro-VC (Student Experience), University of Bath and Dr Theo Papadopoulos Co-Director of CASPS. CASPS and the co-organizers gratefully acknowledge the support of Community Engagement Team and the financial contribution of the University of Bath's Alumni Fund and Knowledge Exchange Fund in covering the catering and other costs for this event. Diana recent publication co-authored with Dr Kate Woodthorpe (SPS) contains evidence
and recommendations for end-of-life care policy in the care home context. The paper
explores how care home staff collaborate with GPs to prescribe medication for the
management of dying symptoms to residents ahead of need. This process is called

This expert commentary focused on the importance of embedding social cohesion in policy domestically and cross-nationally. Emeritus Professor Richard Velleman

Richard Velleman is Emeritus Professor in the Department of Psychology and is also affiliated with CASPS. He currently divides his time between two main work areas.

He founded and is the co-Director of the Addictions and related Research Group, part of Sangath, Goa, India - https://sangath.in/addictions-research-group/. The ARG was set up with the intention to create a world-class research group, focused on addictions and related mental health issues in low resource settings. The vision for the ARG was to create a sustainable group of researchers and health workers, championing the field of addictions (and related) research in India. This has led to projects around many aspects of 'addiction', including those developing and evaluation the provision of counselling to families of people with drinking problems and to survivors of domestic violence; as well as work within the wider global mental health field.

He also founded and is a Trustee and Treasurer of AFINet (Addictions and the Family International Network - www.afinetwork.info], a free-to-join Network, providing a platform which:

- brings together researchers, policy-makers, practitioners, and experts by experience;
- promotes the well-being of family members, friends and colleagues who are affected by or concerned about another person's problems with or addiction to alcohol, drugs or gambling; and
- develops research, policy, practice, and advocacy in the field.
