#### Distinguished Speaker Visit (March 4-8<sup>th</sup>, 2024)

During the week of **4**<sup>th</sup>-**8**<sup>th</sup> **March 2024**, CGR&IS will be hosting <u>Professor Ron Boschma</u> (University of Utrecht) as part of the School's Distinguished Speaker series. Ron is one the world's most distinguished economic geographers and has published widely and extensively especially on regional innovation, diversification and the implications for regional policy. Abstract: Over the past forty years the literature on regional economic development has shown the importance of social capital as a driver of trust and cooperation, which are critical factors for SME competitiveness and their local economies. However, the former basis of social capital has changed dramatically in recent years. Nowadays, our societies are much more heterogeneous than in the past, thus require a different type of social capital to regenerate new bases for trust and cooperation. Robert Putnam led the way by identifying a bridging type of social capital that can serve this purpose as it helps to link people from different background through voluntary civic and political engagement. Echoing his work, we take a step further to discuss the importance of ethnic communities that bring in their values, routines, social support and business engagement which produce additive outcomes for regional economic development. This discussion is supported by some preliminary evidence related to the impact of ethnic minorities' entrepreneurship in business teams on economic growth in the UK context.

The second seminar will be a webinar by **Dr Ilaria Mariotti (University of Venice)** and will be hosted in late April. We are awaiting full details of the webinar, but we will inform you in due course. Further details of both these seminars will be circulated by email separately.
