University of Bath: Scheme of Delegation

This Scheme of Delegation sets out the authority held by Council and the Vice Chancellor and President and that which has been delegated to Committees or individual Officers of the University to exercise on their behalf.

The principal source of authority is derived from the University's Charter and Statutes but also its Ordinances and Regulations and legal obligations which it is required to meet.

Council is the supreme governing body and carries unambiguous, collective responsibility for overseeing the University's activities and determining its mission and strategic direction. Council ensures compliance with the Charter, Statutes Ordinances and other provisions regulating the university and its framework of governance.

Council comprises 21 members. In addition to the Vice Chancellor it has 11 lay members (including a lay chair) 4 members elected by Senate plus the Chair of Academic Assembly, 2 members elected by professional staff and 2 student sabbatical officers. In reaching its decisions it will take advice from Officers and staff of the University and such external experts as it deems appropriate.

Senate is the supreme academic body of the University and is responsible to Council for all matters of academic governance. Subject to the provisions of Statutes and Ordinances and any powers reserved to Council, Senate has the power to take measures or actions to further the best interests of the University as a place of teaching, learning and research. It may also delegate such of its powers as it sees fit to individuals or committees as appropriate.

The Vice-Chancellor and President is the academic leader, Chief Officer and Accountable Officer of the University and, by virtue of this position, has the authority to take certain decisions on behalf of the University. With regard to academic matters, the Vice-Chancellor and President is the ex officio Chair of Senate. Under Senate Standing Orders they are also authorised to act on behalf of Senate during vacation and other times to deal with urgent business, subject to certain reporting and consultation requirements. With regard to financial matters, the Vice-Chancellor and President may authorise any recurrent expenditure from the University budget as approved by Council, as well as capital expenditure within agreed limits. Further details are specified in the schedule below.

An extract of the relevant sections of the Charter and Statutes, outlining the specific responsibilities granted Council, Senate and the Vice Chancellor and President, is attached in Appendix 2.

Matters where the Vice Chancellor and President is listed as the final authority, may be delegated at their absolute discretion without further recourse to Council and similarly can be withdrawn by him and reallocated elsewhere. However, it is expected that the Head of Strategic Governance will be notified of any such changes in a timely manner so that this document can be kept up to date and available on-line as a source of reference. reference document.

Under exceptional circumstances Council reserves the right to determine any matter which it has previously delegated under this Scheme. However, the rationale for this course of action must be formally noted at the next meeting of Council.

Where any decision taken in accordance with this Scheme is expected to have significant implications or is known to be sensitive, the Committee or Officer to whom the authority is delegated should consult appropriately before exercising their delegation. Any Officer or Committee to whom power to act has been delegated can decide that it is not appropriate to exercise their delegation on a specific occasion and can refer the decision back to the entity or person listed as the final authority for decision.

No scheme of delegations can cover every eventuality so if in any doubt, you are required to seek guidance from the Head of Strategic Governance (HOSG) Similarly if you believe any aspect of the current delegations is impeding the smooth and timely running of the institution, you should continue to operate within the stated delegations but immediately bring the matter to the attention of HOSG for further consideration.

This Scheme will be maintained on an ongoing basis by HOSG. Any amendments approved by Council will take immediate effect, as will changes made by the Vice Chancellor and President where they are the final authority. Additionally, the content of the Scheme will be formally reviewed annually by ARAC and periodically by finance with respect to finance specific elements.

Exercising Delegated Authority

In exercising delegated authorities, your decisions should:

- Always be consistent with the University's values, aims and objectives
- Never exceed the level of authority granted to you and must be within the allocated and approved budget
- Relate only to your sphere of operation ie not require the commitment of other areas of the university without their prior consent and following consultation as appropriate with relevant parties at a scale proportionate to the impact of the decision.
- Be taken only after consideration of the relevant documentation and in line with University policies and procedures
- Be taken in advance of any commitment of expenditure
- Be recorded in line with the University records retention policy such that if required due process could be demonstrated.

Council	Charter	12. There shall be a Council of the University (herein called 'the Council') which shall, subject to the Statutes, be the
		governing body of the University and shall have the custody and use of the Common Seal, and shall be responsible
		for the management and administration of the revenue and property of the University and shall, subject to the
		powers of the Senate as provided in this Our Charter and the Statutes, have general control over the conduct of the
		affairs of the University with power to manage all matters not provided otherwise by this Our Charter or by the

SECTION 17 Functions of the Council Statutes Subject to the Charter, these Statutes and Ordinances the Council in addition to all other functions vested in it, shall have the following functions: 17.1 To appoint a Chair not being a member of Staff or Student of the University who shall hold office for three years and shall be eligible for re-appointment. The Chair shall not hold office for more than three periods of three years, except in exceptional circumstances. 17.2 To appoint if the Council so wishes a Vice-Chair from those members of Council not being members of Staff or Students of the University who shall hold office for three years and shall be eligible for re-appointment for one or more further periods of three years. 17.3 To appoint members to the Joint Committees referred to in Sections 3 and 5 of these Statutes. 17.4 To nominate to the Court persons for appointment as Pro-Chancellors. 17.5 To appoint a Treasurer. 17.6 To appoint members of the Court as provided for in these Statutes. 17.7 After consideration of such reports, recommendations or nominations as are required by these Statutes to appoint the Vice-Chancellor, the Deputy Vice-Chancellor, Pro-Vice-Chancellors, the University Secretary, Heads of Schools and the University Librarian. 17.8 To determine the method of appointment, conditions of appointment and service, and remuneration of all Staff of the University, Academic or otherwise, and of all other persons employed or engaged by the University. 17.9 After consideration of a report from the Senate, to deprive persons of any Degrees or other distinctions or titles conferred on them, and to revoke any Diplomas or Certificates granted to them by the University either itself or jointly or in conjunction with other institutions, and to withdraw all privileges connected therewith. 17.10 On the recommendation of the Senate to institute, combine or discontinue Schools, Departments, Institutes or other academic sections of the University. 17.11 To bring from time to time before the Court and the Senate any matters which in its opinion should be dealt with by these bodies respectively. 17.12 In accordance with Article 29 of the Charter, jointly with the Senate to recommend Special Resolutions to the Court. 17.13 In accordance with Article 23 of the Charter to make Ordinances. 17.14 To govern, manage and regulate the finances, accounts, investments, property, business and all affairs whatsoever of the University, and for these purposes to appoint bankers, and any other officers or agents whom it may think fit to appoint, and to cause proper books of account to be kept for all sums of money received and expended by the University, and for the assets and liabilities of the University, so that such books give a true and fair

view of the state of the University's affairs and explain its transactions; provided that, before determining any

question of finance which affects the academic policy of the University, the Council shall take into consideration any recommendation or report thereon by the Senate.

17.15 To invest any moneys belonging to or held by the University in any manner as the Council shall from time to time think fit, in any part of the world, or in the purchase of freehold or leasehold hereditaments in the United Kingdom, including rents; provided that in the case of moneys held by the University as trustees the powers conferred by this paragraph shall be exercised subject to the provisions of the governing trust instrument.

17.16 To sell, buy, exchange, lease and accept leases of real and personal property on behalf of the University.

17.17 To borrow money on behalf of the University, and for that purpose, if the Council thinks fit, to mortgage, or charge all or any part of the property of the University, whether real or personal, unless the conditions of any Will, Deed or Gift or other similar instrument are thereby contravened, and to give such other security whether real or personal property or otherwise as the Council may think fit.

17.18 To provide the buildings, premises, furniture and equipment and other means required for carrying on the work of the University and maintaining its efficiency and well-being.

17.19 To provide at its discretion for the welfare of all persons in the employment of the University or formerly in the employment of the University or of the College and the spouses, widows, widowers, and dependants of such persons including the payment of money, pensions or other payments and to subscribe to benevolent and other funds for the benefit of such person.

17.20 To consider, adjudicate upon, and, if thought fit, redress any grievance of the Academic and other Staff of the University, the Graduates and the Students of the University who may for any reason feel aggrieved otherwise than by an act of the Court or by an act taken in accordance with the provisions of Sections 19 or 25 of these Statutes.
7.21 To enter into, vary, carry out and cancel contracts on behalf of the University, subject to the provisions of

17.22 To determine all University fees.

Section 25 of these Statutes in those cases where Section 25 applies.

17.23 To accept, reject or refer back any recommendation made by the Senate; provided that no such recommendation may be rejected unless the Senate is informed of the reasons for such rejection and is given an opportunity to comment thereon to the Council.

17.24 To call for reports from the Senate and by receiving such reports to review the work of the University.

17.25 Subject to the powers of the Senate, to take such action as it may think fit to advance the teaching and research, the interests and general efficiency of the University, and to provide for the recreation and welfare of the Students and Staff of the University.

17.26 To establish Joint Committees of the Council and representatives of the Students' Union and to prescribe the method of appointment of such representatives and the functions of such committees.

17.27 To select a Seal and a Mace for the University and to have the sole custody and use of the Seal and under
detailed provisions to be contained in the Ordinances to provide that the use of the Seal and its witnessing or the
execution of deeds on behalf of the University by Officers of the University and those persons nominated by the
Council for this purpose may be dealt with as if the University was a Company incorporated under the provisions of
the Companies Act 1985 or under any legislation in substitution therefor and in accordance with any resolution of
the Council relating to the use of the Seal or the execution of deeds.

- 17.28 To exercise all such powers as are or may be conferred on the Council by the Charter, these Statutes and the Ordinances and to carry them into effect.
- 17.29 To appoint a Secretary to the Council in accordance with Section 10 of these Statutes.
- 17.30 To appoint the External Auditor.
- 17.31 On the recommendation of the Senate to make, amend, add to or repeal Statutes in accordance with Article 21 of the Charter.
- 17.32 To consider representations from the Court on any matter affecting the University.
- 17.33 To delegate, upon such conditions as it may determine, and to revoke the delegation of, any of its functions to committees of the Council, joint committees of the Council and the Senate, the Vice-Chancellor or other Officers of the University. Such delegation may include delegation of powers of appointment and powers of investment. Any delegation of function shall be explicit and a matter of record.
- 17.34 To delegate the management of investments to one or more fund managers who are authorised and exempted persons under the Financial Services and Markets Act 2000.

- 8. THE COUNCIL
- 8.1 Election of Four Members of the Senate by the Senate to serve on the Council
- (a) The election of Four Members of the Senate by the Senate to the Members of the Council shall be conducted by secret ballot in accordance with such procedure as the Senate shall prescribe.
- (b) Members of Council elected by Senate who are subsequently appointed to posts of either Pro-Vice-Chancellor or Dean be required to resign their elected membership of Council. Persons in attendance at meetings of Council shall not be included in this election.
- (c) Members of Senate elected to Council shall serve for a period of three years or such lesser period as the person elected remains a member of Senate.

University of Bath - Ordinances

8.2 Election of One Member of Senate by the Academic Assembly to serve on the Council

- (a) The Academic Assembly shall elect a person to fill the vacancy on the University Council in accordance with subparagraph c(ii) of paragraph 1 of Section 16 of the Statutes for a period of three years, or such lesser period as the person elected remains a member of the Senate.
- (b) The candidates in this election shall be all those members of Senate elected in accordance with sub-paragraph (b)(ii) of paragraph 1 of Section 18 of the Statutes who are not otherwise members of Council and whose period of office on Senate extends for at least two complete sessions subsequent to the election.
- (c) The University Secretary shall issue a voting paper giving the names of the candidates as defined in (b) above to all members of the Academic Assembly.
- (d) The votes shall be counted under the direction of the University Secretary.
- (e) Members of Council elected by Academic Assembly who are subsequently appointed to posts of either Pro-Vice-Chancellor or Dean be required to resign their elected membership of Council.
- 8.3 Election of One Member of Non-Academic Staff to serve on the Council
- (a) Members of staff who are not members of the Academic Assembly and who are on a full-time or fractional contract shall elect a person to fill the vacancy on the University Council in accordance with sub-paragraph c (iii) of paragraph 1 of Section 16 of the Statutes for a period of three years, or such lesser period as the person elected remains a member of University staff but is not a member of the Academic Assembly.
- (b) Any member of staff who is not a member of the Academic Assembly and who is on a full-time or fractional contract is eligible to stand for election to Council in this election.
- (c) When there is a vacancy for a member of staff who is not a member of the Academic Assembly to serve on Council, the University Secretary shall give notice to members of staff who are not members of the Academic Assembly by inviting seconded nominations for election to be submitted to the University Secretary not later than a specified date. Staff may suggest themselves for election but require both a separate proposer and seconder, all of whom must be eligible to vote.
- (d) After receipt of nominations the University Secretary shall provide to all members of staff who are not members of the Academic Assembly and who are on a full-time or fractional contract voting instructions, the names of the candidates nominated and the latest date by which votes must be cast.
- (e) The votes shall be counted under the direction of the University Secretary.

Ordinances 9. THE SENATE
9.1 Election of Members of the Academic Assembly to serve on the Senate
(a) The University Secretary shall give notice to the Chair of the Academic Assembly of the number of vacancies on
the Senate when these are to be filled by election from the Academic Assembly. The Chair shall give notice to all
members of the Academic Assembly that seconded nominations for election are to be submitted to the University
Secretary not later than a specified date. Staff eligible to participate in the election are members of Academic
Assembly on full-time or fractional contracts. Staff may suggest themselves for election but require both a separate
proposer and seconder, all of whom must be eligible to vote.

- (b) After receipt of nominations the University Secretary shall provide to all members of Academic Assembly, who are on a full-time or fractional contract, voting instructions, the names of the candidates nominated and the latest date by which votes must be cast.
- (c) The votes shall be counted under the direction of the University Secretary. If there is a tie, this will be resolved by drawing lots.
- (d) In accordance with Section 18.1(b)(ii) of the Statutes, the number of Professors elected to serve on the Senate by the Academic Assembly shall not exceed three at any one time.
- (e) If one or more of the vacancies is for a member to serve for less than three years, then the person with the lowest number of votes among those elected shall serve for the shortest period.
- (f) Members of Senate elected by Academic Assembly who are subsequently promoted to a Professorship be required to resign their original elected membership of Senate. A casual vacancy may be filled by the candidate with next highest number of votes, if there has been an election in the previous six months.
- 9.2 Appointment of Twelve Professors to serve on the Senate

The following procedure shall be adopted to elect twelve Professors to serve on Senate under the provisions of Section 18.1(b)(i) of the Statutes:

- (a) An election shall be held once in each year.
- (b) The University Secretary shall, at the appropriate time, notify all the professors who are not members of Senate ex-officio that the said election is about to be conducted and how many vacancies there are. The Professors eligible to participate in elections are those with the title of Professor who are on full-time or fractional contracts.
- (c) Any professor so notified may, by the date prescribed by the University Secretary, withdraw from the list of candidates for that year.
- (d) If the number of candidates remaining after the prescribed date does not exceed the number of vacancies, the University Secretary shall declare those candidates elected.
- (e) If the number exceeds the number of vacancies, an election shall be conducted in the following manner:
- (i) Professors are elected for a term of three years and may be re-elected for a further three years, up to a maximum of six years.
- (ii) The University Secretary shall declare the number of vacancies which remain to be filled and shall then conduct an election among the remaining candidates.
- (iii) The University Secretary shall provide to all Professors eligible to vote voting instructions, the names of the Professors standing for election and the latest date by which votes must be cast. The votes shall be counted under the direction of the University Secretary.
- (iv) Each member may vote for as many candidates as there are vacancies. When the votes have been counted, the University Secretary shall organise a second voting round including the names of the eight candidates who have

received the greatest number of votes. Ties in the first ballot for eighth place shall be included in the second ballot. Each voter in the second ballot shall have as many votes as there are vacancies.

(v) The candidates who have received the greatest number of votes in the second ballot shall be declared elected. Ties in the second ballot shall be resolved by drawing lots.

(vi) In the event of a casual vacancy, the unsuccessful candidate who had the next highest number of votes in the second ballot is appointed, if there has been an election in the previous six months. If there is more than one unsuccessful candidate tied on the next highest number of votes, this will be resolved by drawing lots.

9.3 Chair of the Programmes and Partnerships Approval Committee

The Chair of the Programmes and Partnerships Approval Committee shall be an ex-officio member of Senate. 9.4 Student Members of Senate

The student members of Senate are the President, Education Officer and Postgraduate Officer of the SU and one other student elected by campus ballot.
